I agree that EVOSONIC e.V., as the responsible body, stores, processes and uses the personal data collected in the membership application, such as company name, surname, first name, date of birth, address, e-mail address, training status, telephone number, mobile number and bank details, exclusively for the purpose of membership administration, the collection of fees and the transmission of association information by the association. Parts of this data will only be transmitted and used within the scope of the association's statutory purposes, e.g. the promotion and organisation of special broadcasts, video streams, events and club celebrations in-house and on the association's internal website (www.evosonic.org). The individual member may at any time raise objections to such publication of his or her data to the Board of Directors.

Personal data will only be transmitted to third parties in the context of the storage and processing of membership data in the association's accounting system and membership lists, as well as for the documentation of general meetings with resolutions vis-à-vis legal supervisory bodies. Data will not be used for advertising purposes. In addition, member data is stored and processed in a secure internal association environment. Access to it is only permitted to authorized members of the Executive Board within the scope of their duties. They have also been informed about their data protection obligations.

Upon termination of the membership, the personal data and the assigned membership number will be deleted, unless they have to be stored in

accordance with tax law requirements or for insurance matters and documentation obligations and vis-à-vis legal supervisory bodies and/or in the acquisition of public funding. Within the framework of the provisions of the Federal Data Protection Act, each member has the right to information about the personal data that is stored about him or her by the responsible body. In addition, in the event of incorrect data, the member has the right to correct it.

I agree that EVOSONIC e.V. may publish pictures of broadcast-related or social events from the life of the association on the website of the association or other association publications and/or pass them on to the press for the purpose of publication without special consent. Images of named individuals or small groups, on the other hand, require the consent of the persons depicted. I agree that EVOSONIC e.V. may monitor the broadcasting rooms with a video camera for the purpose of inventory protection and documentation of transactions with insurance concerns.
