



FEE & MEMBERSHIP REGULATIONS EVOSONIC e.V.

## Fee and Membership Regulations

§1

In accordance with its statutes, EVOSONIC e.V. adopts the following fee and membership regulations:

1.1 The amount of the monthly membership fee is shown in the following table and is to be paid in one lump sum for the actual membership period in the course of a calendar year, if possible:

- Sustaining member (individual)	at least	5,00 € / per month
- Sustaining member (reduced contribution)	at least	2,50 € / per month
- Sustaining member (legal entity)	at least	10,00 € / per month
-Full	at least	10,00 € / per month

- 1.2 At the request of the member to the treasurer, the annual fee is reduced to 50 percent of the full membership fee if a member can prove that he or she is enrolled as a student or pupil at a university or college or other continuing education school. The discount is valid for the financial year requested.
- 1.3 In addition to the above provisions, the Board of Directors may grant reductions or waivers of membership fees if special circumstances relating to the economic circumstances of the member concerned justify this.
- 1.4 There is no admission fee.

§2

2.1 In the first two calendar months of each financial year, the association sends the contribution invoices for the entire financial year to each member. It will be sent to the last postal address provided by the member by simple letter. If the member does not object, the contribution invoice can be sent by e-mail.

- 3.1 The membership fee is due in advance upon receipt of the invoice. It must be paid to the association's contribution account by the end of two weeks at the latest. The decisive factor for the punctuality of payment is the date of receipt. In the event of an early termination of the association's membership, no contributions will be refunded.
- 3.2 If the member authorises the association to collect his contributions by means of cashless payment transactions, and contributions collected in this respect are recalled for reasons for which the member is responsible (e.g. due to insufficient funds in his bank account or incorrect information provided by the member about his bank details), the member must reimburse the association for the costs incurred as a result.

## **§**4

- 4.1 If the payment of the amount is not made in time in accordance with § 3 above, a reminder fee of 5 euros will be charged. It sets a grace period with a fixed payment date, which does not constitute a deferral. This is measured according to the circumstances to be dutifully assessed by the Executive Board. As a rule, the last payment date is to be set to a calendar day that is two weeks after the expected date of receipt of the reminder by the member.
- 4.2 A note must be included in the payment reminder stating that the defaulting member must expect to be expelled from the association in accordance with § 4 of the statutes if the grace period expires without success.

## §5

5.1 Supporting membership is open to those persons who want to support the association in its statutory goals. Supporting members pay a voluntary membership fee to be determined by them, which may not be less than an annual fee of 60 euros. A sustaining member is only entitled to limited membership rights, he or she is not a member of the association in the sense of association law. A sustaining member does not have the right to vote in the General Assembly.

## §6

6.1 These Fee and Membership Regulations come into force on the day of their decision by the General Assembly.
